The Urban Forestry Division is responsible for the care and maintenance of the trees throughout the City of Philadelphia. The maintenance of trees located in neighborhood parks and playgrounds is accomplished primarily by Parks & Recreation tree maintenance crews. These crews perform work city-wide which includes pruning, removal, and planting of new trees.

The Recreation Specialty Instructor (RSI) will serve as a Park Tree Intern to assist in the data collection and inventory of park trees by recording the species, size, and location of trees located in the City of Philadelphia. The Park Tree Intern is a field-based position.

- Under the supervision of an Arborist, collect and record data on street trees throughout the City of Philadelphia
- Use the Collector App for ArcGIS online with an iPad
- Follow established Philadelphia Parks & Recreation protocols to ensure quality, expertise and consistency of the data
- Other related duties as assigned
